_____ Doc's K9 Stay & Play agrees to exercise due diligence and reasonable care to keep the premises sanitary and properly enclosed. All pets are handled or cared for by Doc's K9 Stay & Play Staff without liability on Doc's K9 Stay & Play or Doc's K9 Center or Dr. Karen Garelick part for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other pet(s) or property by said pet, or from other unavoidable causes, due diligence and care having been exercised.

_____ Owner is aware of the risks involved with their pet interacting with other pets in a group setting. These include, but are not limited to scrapes, cuts, bites and viral and bacterial infections.

_____ Should any pet become ill or seem to be in need of medical consideration, Doc's K9 Stay & Play reserves the right to administer aid and/or use any available veterinarian. Any expenses so incurred should be paid by the Owner of the sand pet in addition to the fees incurred for services provided by Doc's K9 Stay & Play.

_____ Owner agrees to pay the rate of services in effect on the date their pet is checked into Doc's K9 Stay & Play. Cancellation fees apply if 24 hour advance notice is not given.

_____ **Pet must be current on all vaccinations: Rabies, K9 Distemper, Parainfluenza, Bordatella, Hepatitis, Parvo, Lepto, K9 Flu and mandatory monthly scheduled prevention program for flea/ticks. Heartworm and fecal negative (routinely tested on preventative.)** Doc's K9 Stay & Play has the right to refuse any dog not current with these protocols.

_____ Owner is aware that reservations are required 24 hours in advance. Likewise, notice of reservation cancellation must be received no later than 24 hours prior to scheduled appointment. If notice is not received, owner agrees that their daycare package will be charged for the visit.

_____ Owner agrees that he pet will be picked up by the Owner or a pre-approved Owner's Agent by closing time at the scheduled pick-up time. **Owners will be charged a \$5.00 for every 5 minutes late fee pick up after 6:00 PM.**
